## About the department

The Church of England is continually striving to improve its safeguarding practices. The 2020 report by IICSA on the Church highlighted failures in respect of child sexual abuse and, more broadly, the challenges facing the Church to get safeguarding right.

The Church's aspiration is that safeguarding is not experienced and approached as a matter of administrative compliance. Rather, it should be what the Church is – something that flows from its core beliefs and values, part of its DNA.

The Church has made important and positive strides over recent years. There is, however, still much to be done to keep children and vulnerable adults safe, and to promote their well-being.

The Church is a complex collection of different bodies. Most of the safeguarding work is carried out locally within the 42 dioceses and cathedrals in England. This work is supported centrally by a National Safeguarding Team (NST).

# What you'll be doing

The purpose of this role is to manage the final delivery stage and closure of the IICSA 1&8 Regional Model Pilot Project. The Project Manager will work closely with the Business Change Specialist and Safeguarding Programme Manager to oversee the national implementation of IICSA Recommendation 1, support the ongoing Independent Safeguarding Audit Programme (IICSA Recommendation 8) and transition from the project phase to business-as-usual.

- Owning the project plan and tracking project deliverables
- Writing, and where appropriate presenting, papers and routine updates for other governance bodies for review by SRO
- Regularly reviewing and monitoring project documentation (risk and issue register, decisions log, lessons learned etc)
- Tracking, resolving and/or escalating issues and risks as necessary
- Ensuring compliance with the project management framework and best practice
- Ensuring the agreed definitions of project scope, goals and deliverables are adhered to in all documentation
- Planning and running regular project team meetings
- Representing the project at programme and other meetings
- Overseeing the administration of the certification process for IICSA Recommendation 1
- Managing recruitment to project related roles
- Supporting the Senior Project Manager in task management for the Project Support Officer
- Engaging with internal and external stakeholders
- Coordinating legislation and policy change processes
- Contributing to planning for project closure and transition to business as usual
- Contribute to the planning and facilitation of items for team days
